SC-SIC Website

The 2013-14 Training Schedule has been archived on the SIC Training Dates and Locations page of the SC-SIC website, http://sic.sc.gov. There are currently nine SIC trainings scheduled for the 2014-15 school year.

Current Home Page highlights include reminders to Councils to report their SIC membership to SC-SIC by November 15, a description of and link to *In the Loop* (SC-SIC newest emailed publication for SIC members and friends) and a link to competitions and workshops currently being offered by SC Economics. Offerings for SIC brochures and lapel pins are featured, as is the link for the current issue of the SIC handbook, *The Basics* (Seventh Edition). SIC District Contacts and members are being asked to download and use this version of the Handbook while the latest edition is in production.

SC-SIC Member Network (includes data from the 2013-14 school year)

- Total number of schools falling under laws governing SICs as of 06/09/14 (2013-14 school year): 1,131 (This figure does not include three schools that convene SICs but are not mandated to do so, and reflects the addition of one new school since 02/03/14.) These are the latest available figures.
- Total number of SIC members reported as of 06/09/14 (2013-14 school year): **14,278** (up from 14,010 on 02/03/14). To date, 769 members have been reported in advance of the November 15 reporting deadline.
- Total number of SICs in compliance as of 06/09/14 (2013-14 school year): **1,017.** (This number includes three "Career, Tech and Other" category schools, which are not mandated to convene SICs.)
- Total number of SICs out of compliance as of 06/09/14 (2013-14 school year): 117.
- Compliance numbers for the 2014-15 school year will be available after the November 15 deadline.
- Percentage of SICs in compliance for the 2013-14 school year: 90%.

Report to the Parents Uploads

811 *Reports to the Parents* were uploaded by SC-SIC Member Network users in the 2013-14 school year. This reflects a steady yearly increase in uploads since the function was first initiated in 2010.

421 *Reports* were uploaded to the database in 2010-11, 564 in 2011-12 and 690 in 2012-13. Councils are encouraged to continue to upload their *Reports* after the deadline, so *Reports* for earlier years may continue to be added.

SICs have demonstrated a willingness to share their *Reports* via the *Member Network* database and are strongly encouraged to do so by a majority of the school districts. By mandate, the *Report to the Parents* must be distributed to the community by April 30 of each year; SICs voluntarily upload *Reports* to the *Member Network*.

Report to the Parents Uploads, continued

Reports are available for public viewing via the **View the SIC Members (Read-Only)** link on the SC-SIC Member Network. (https://sic.ed.sc.edu/network/)

The *Report to the Parents* offers publicly accessible information about what Councils across South Carolina are doing and accomplishing.

Social Media

The SC-SIC Twitter account now has 1,617 followers (up from 1,465 as of 06/13/14). Use of Twitter by SC-SIC provides a communications conduit to education groups and professionals across the country as well as accelerated access to education and civic engagement news, blogs and journal articles on a wide variety of topics, and immediate contact with the community. Media personnel, political figures and key education players in South Carolina and beyond follow @SCSIC and often "retweet" or mention @SCSIC (our Twitter "handle") in their tweets, continuing to raise our public profile and advancing a key strategic planning goal. Among @SCSIC followers are several educators, political figures, organizations, and media personnel from other states and countries. Also of great use is the accessibility of breaking news obtainable through Twitter lists of media, education outlets and those involved in the South Carolina political landscape.

The SC-SIC Facebook Page has 588 "Likes" (up from 576 on 06/13/14). Many links to information and articles that are shared on Twitter are also posted here, though less in number due to the real-time posting and faster pace of Twitter. Facebook, like Twitter, serves to increase our search engine rankings, again advancing our public profile. We encourage Councils to have their own Facebook pages and /or Twitter accounts to facilitate communication among members and to inform the school community of ongoing projects.

It should be noted that each quarter has shown an increase in Facebook and Twitter followers. Social media has proven to be an essential tool in maintaining the SC-SIC public presence and in facilitating information flow.

In the Loop

In the Loop is the latest email blast offering from SC-SIC and replaces the former SIC Clips & Quips. It serves to keep SIC members and friends informed of events, dates, news, and other happenings. In the Loop is sent to all SIC members and supporters who share their email addresses with us; the first issue can be found on the SC-SIC website at http://sic.sc.gov/publicationsanddownloads/Pages/SC-SICIntheLoop.aspx.

SIC Clips & Quips archive

The *Clips and Quips* archive is retained on the SC-SIC website at http://sic.sc.gov/publicationsanddownloads/Pages/SC-SICClipsandQuips.aspx.

Council News

The *Council News* electronic newsletters are emailed to all SIC members and friends that share their email address with us. They are posted to the SC-SIC website at http://sic.sc.gov/publicationsanddownloads/Pages/CouncilNewsandArchives.aspx.

SC-SIC listserv

At this time the primary SC-SIC listserv of members and friends consists of over 11,300 email addresses. Addresses are deleted by individual request; subscribers are also able to independently leave the list. While exact numbers are not available, judging by the small number of returned emails received we have reason to believe that the great majority of these emails are valid.

Programs and Research

Continued to Implement Engagement for Outcomes Pilot

- All four SICs remaining in the pilot program have confirmed their desire to participate through December 2014. They are beginning to meet this week.
- At least one of the SICs has reported in on planning activities they conducted during the summer months. Three of the four SICs are well positioned to hit the ground running this fall with the specific goals and activities that they developed last year. The emphasis in working with these schools will be to move to the active implementation of plans and to conduct simple evaluation exercises.
- The fourth school has experienced problems with organizational capacity. SC-SIC will be working with the principal to strengthen the SIC as an organization before attempting to return to work on the GTO steps.
- With Tom Hudson, presented session at SCASA Summer Institute in Myrtle Beach on the *Engagement for Outcomes* program.
- Continued work in converting materials, tools and research developed for *Engagement for Outcomes* schools into more generic formats for use by all SICs.

Family and Community Engagement Book Program

• A portion of the small surplus that SC-SIC had at the end of the fiscal year was used to purchase approximately 15 additional family engagement guidebooks by Steve Constantino as well as five copies of *Beyond the Bake Sale* by Karen Mapp et al. We received over 20 requests for the Constantino book over the past year – a significant percentage of which came from the state's rural, high need school districts.

Publications

- Completed a draft tri-fold SIC outreach brochure targeting parents and community members in particular. The brochure is intended for distribution by local SICs at SIC tables at school events, by the school office, or as otherwise needed, and can be modified for individual use. It is expected that this brochure will be translated into Spanish, and that it will be part of a series that will include brochures targeting high school students and teachers.
- Began work on the new SC-SIC handbook intended to replace the current *Basics* Handbook.
- Developed draft sample SIC parent election ballot with instruction sheet and a sample SIC parent candidate statement sheet with background sheet. It is expected that these will be posted on the SC-SIC website with other samples, examples and fact sheets about holding elections for different types of SIC representatives. They will also be referred to in the new Handbook as examples that can be accessed on the SC-SIC website.
